3. HAZARDS IDENTIFICATION**EMERGENCY OVERVIEW**

IMMEDIATE CONCERNS: CAUTION. OSHA-COMBUSTIBLE LIQUID. Harmful if swallowed, in eyes, inhaled, or on the skin. Avoid contact with skin, eyes, and clothing. Avoid breathing vapors or spray mists of this product. Do not use or store near heat, open flame, or any other ignition source.

POTENTIAL HEALTH EFFECTS

EYES: Causes temporary irritation, tearing, and blurred vision.

SKIN: Can cause mild skin irritation. Can cause a burning or prickling sensation on more sensitive areas (face, eyes, mouth).

SKIN ABSORPTION: Can be harmful if absorbed through the skin.

INGESTION: Can cause stomach irritation, resulting in nausea, cramps and vomiting. Can cause nervous system disorders, such as fatigue, dizziness, headaches, lack of coordination, tremors and unconsciousness.

4. FIRST AID MEASURES

7. HANDLING AND STORAGE

GENERAL PROCEDURES: Do not use near heat, open flame, or any other ignition source.

Mechanical ventilation should be used when handling this product in enclosed spaces. Wearing a respirator is not normally required when handling this product, but recommended in the absence of proper mechanical ventilation. Do not contaminate water, feed or food by storage, handling or disposal. Read and observe all precautions and instructions on the label.

STORAGE: Store in a cool, dry place. Keep container closed. Do not use or store near heat, open flame, ignition sources, or near strong acids, bases, and oxidizers. Emptied containers may retain product residues.

EYE EFFECTS: Produced conjunctival irritation in 6/6 albino rabbit eyes, clearing by 7 days. Corneal opacity was visible for 2/6 animals but was not visible by day 4. No iritis was observed during study.

SKIN EFFECTS: Produced a primary skin irritation index of 0.08 in albino rabbits.

SENSITIZATION: When applied dermally to albino guinea pigs, this product appears to be a dermal sensitizer.

COMMENTS: None of the components present in this material at concentrations equal to or greater than 0.1% are listed by IARC, NTP, OSHA or ACGIH as being carcinogens.

Marginally higher incidences of benign liver tumors in mice were observed following lifetime high dose exposures to PBO. The significance of this observation is questionable and under review. The doses at which tumors were observed for PBO greatly exceeded potential human exposure from labeled uses.
