3. HAZARDS IDENTIFICATION

POTENTIAL HEALTH EFFECTS: EMERGENCY OVERVIEW

Carcinogenicity/ Oncogenicity: Pyrethrins	Pyrethrum has been tested in chronic feeding studies in mice and rats. Slightly elevated incidences of benign tumors of the thyroid and liver were seen in rats following high doses of Pyrethrum. Further detailed scientific studies into the mechanism causing these responses indicate that these effects in the animals only occur at doses greatly exceeding the likely human exposure levels. Thus, the effects seen in animals are of little relevance to humans.

4. FIRST-AID MEASURES

FIRST AID PROCEDURES:

EYES:	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
